Guest Policies for Cedar Hill Club

The following rules are established to ensure safe and sanitary operation of CHC facilities for all members and their guests. Parents are responsible to see that their children observe all rules and obey instructions. Guests who disregard requests of lifeguards or management to comply with these rules will be required to leave CHC immediately. **Failure of a member's guest to comply with these rules shall be sufficient cause for SUSPENSION of the sponsoring member as provided by CHCs By-Laws.**

1. All persons using any of CHC's facilities do so at their own risk. CHC is NOT responsible for accidents or injury or for loss or damage to personal property sustained in connection with the use of the club's facilities.
2. No food is allowed in the fenced pool area except for snacks on "Snack Sundays." Food may be consumed in the fenced in picnic area only.
3. Glass containers are not permitted in the pool area.
4. Inflatable toys, including rafts, tubes, etc., as well as ANY flotation device are only permitted in the kiddy pool.
5. The cost of any property damaged will be charged to the responsible club member.
6. Only one person is permitted on the slide at a time and he/she must come down the slide seated and faced forward.
7. Use of the kiddy pool is restricted to children under 7 years of age and they must be accompanied by an adult.
8. Anyone under the influence of a controlled substance will not be permitted to enter CHC and may be requested to leave.
9. Parents must directly supervise their children while using the playground area.
10. Children under the age of 6 must be accompanied by an adult to the locker room and lavatories.
11. Members and Guests must heed rules posted throughout the club as well as rules documented in the CHC By-Laws or Handbook. Any request by the staff to comply with CHC rules must be followed.
12. Designated containers must be used to recycle beverage cans.
13. Spitting and nose blowing in the pool is prohibited.
14. Children with uncontrolled toilet habits will not be allowed in any pool without proper attire (swim diaper or rubber pants). Swim diapers and rubber pants are NOT permitted in the main pool.
15. Running, pushing, wrestling, or ball playing within the fenced in pool area of CHC is not permitted.
16. Parents are responsible for their children in all areas of CHC at all times.
17. Use of skate boards, roller blades, scooters, and other recreational equipment or toys with wheels is strictly prohibited.
18. Loud radios or televisions are prohibited in the pool area. Earphones are required.
19. Loud, profane or abusive language will not be tolerated.
20. All children 12 and under must take a swim test. Those who do not pass will not be permitted to use the diving boards, slide, or be in the pool unsupervised. The swim test can be taken once every 24 hours.
21. **DIVING AREA:** The diving area is provided for persons wishing to dive. Caution shall be exercised by all persons using this area. Only one person is permitted on the diving boards and steps at a time. Parents should ALWAYS pay careful attention when children are using the diving boards. If a child must come back down the stairs, they should go down the same way they came up, facing the steps. These rules are for your safety.
