



## WHAT IS CEDAR HILL?

Cedar Hill is a private, non-profit, co-operative swim club located in Franklin Township, Somerset County. Its members own and enjoy a 20 acre facility consisting of 3 swimming pools, a dressing room complex with hot water showers, poolside furniture, picnic area, snack bar with enclosed pavilion, and athletic area with 6 regulation size tennis courts, as well as volleyball, handball, basketball, and baseball facilities.

Cedar Hill's main pool is T-shaped with 5,100 square feet of swimming area containing 180,000 gallons of sparkling, artesian well water drawn from our own 320 foot wells. The main part of the pool is 100 feet long and 40 feet wide with a depth ranging from 3 to 5 feet. The remainder is a 35 by 35 foot area for diving.

In addition to the main pool, there is a 75 foot six lane lap pool, 8 feet in depth, which permits unrestricted swimming and is also used for the Club's competitive events.

Children 7 and under enjoy their own 40 by 20 foot pool which slopes from a depth of 6 inches to 18 inches at the center. Nearby is an enclosed, fully equipped play area.

Before entering the pools our water goes through a high volume purification and filtration system. Our specifications exceed state and national standards. All of our operations conform to the swimming pool codes of the New Jersey State Department of Health and the Franklin Township Department of Health. Fully qualified personnel are on duty at all times to safeguard club members and maintain high health and safety regulations.

## FEES

There are four (4) fees associated with membership in Cedar Hill Club.

A **non-refundable** check for \$200 must accompany this application. If the applicant is accepted by the membership Committee, he/she will be invited to join the club or, if necessary, will be placed on a waiting list. If the application is not accepted by the committee, the \$200 check will be returned. Once accepted to the waiting list the prospective member's application fee will not be refunded, nor will it be applied toward the purchase of the member's bond.

When a vacancy exists and a prospective member is invited to join the club, he/she must purchase an \$850 non-transferable, non-interest bearing bond within 20 days of the date of invitation. Failure to purchase the bond within the prescribed time will result in forfeiture of the applicant's position on the waiting list. Once purchased, bonds are redeemable at face value,

only upon termination of membership and in accordance with the by-laws of the Club.

Each year, the Board of Trustees establishes an annual dues assessment fee and work bond fee which is payable by March 1<sup>st</sup>. New members are invited to join CHC in the April/May timeframe. Should a new member be invited to join the club they will have two weeks to remit payment.

## MEMBERSHIP

Membership is on a family basis and includes only the applicant, spouse, domestic partnership, or civil union and unmarried children who have not celebrated their 26th birthday before midnight of Memorial Day of that club year and whose permanent residence is the home of the applicant. Special provisions are included in the by-laws and club rules for permanent house guests and occasional guests. Applicable fees are determined annually by the Board of Trustees.

## CALENDAR

Normally, the Cedar Hill Club opens for Memorial Day Weekend and closes on Labor Day. Facilities are just open on weekends from Memorial Day until the week that schools close, then it is open full-time (Monday through Friday – 10AM to 8PM, Saturday & Sunday – 10AM to 9PM) for the duration of the season. There is a full calendar of athletic and social events for adults, teenagers, and pre-teens. Club operation times are subject to change.
